- (c) The Company will only have liability under Commitment Condition 4 if the Proposed Insured would not have incurred the expense had the Commitment included the added matter when the Commitment was first delivered to the Proposed Insured.

 - (f) When the Policy is issued, all liability and obligation under this Commitment will end and the Company's only liability will be under the Policy.

7. IF THIS COMMITMENT HAS BEEN ISSUED BY AN ISSUING AGENT

The issuing agent is the Company's agent only for the limited purpose of issuing title insurance commitments and policies. The issuing agent is not the Company's agent for the purpose of providing closing or settlement services.

thence with the northwesterly line of the aforesaid 260.080 "Parcel 8" S 50°03'31" W, a distance of 1096.66 feet to a point in the northwesterly edge of a 6" wood post (found), said point marking the northerly most corner of a 30 acres "Parcel 7" as conveyed to Charles S. Rice and Linda D. Rice (O.R. 926, Page 807);

thence with the northwesterly line of the aforesaid 30 acres "Parcel 7" S 50°01'07" W passing the northerly most corner to and continuing with the northwesterly line of a 100 acres "Parcel 3" as conveyed to Charles S. 
thence with the centerline of Tar Pike N 41°38'51" W, a distance of 21.40 feet to the point of beginning, **containing 227.311 acres of land**, of which 226.741 acres being within V.M.S. No. 2705 and 0.570 acre being within V.M.S. No. 2706.

Subject to all legal easements and rights-of-way of record.

Bearings are based upon the Grid Azimuth (Az 111° 52' 47.3") between National Geodetic Survey CORS Station "LEBA" and McCarty Associates Geodetic Local Control Monument "4002" and derived from GNSS observations taken November 3, 2025, utilizing the ODOT Ohio Real Time Network (Trimble Virtual Reference System).

Land surveyed in November 2025, under the direction of Jason C. McConnaughey, Registered Professional Surveyor No. 8509, the survey plat of which is referred to as Project No. S25-318 on file in the office of McCarty Associates, LLC, Hillsboro, Ohio, and found in Surveyor's Record Volume _____, Plat No. _____ of the Clinton County Engineer's Record of Land Surveys
