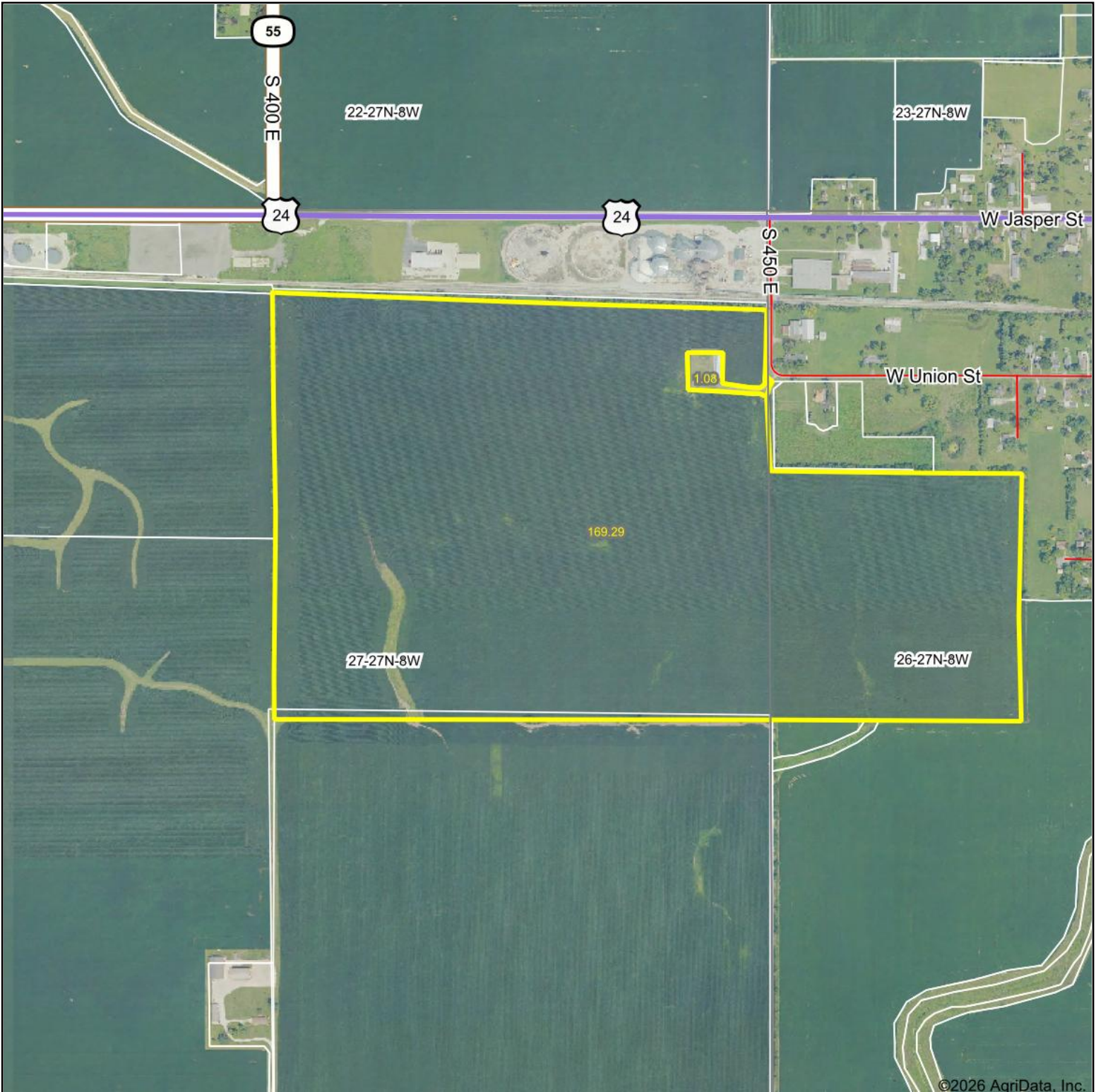
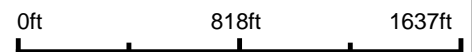


Pepsi Brookman Aerial Map

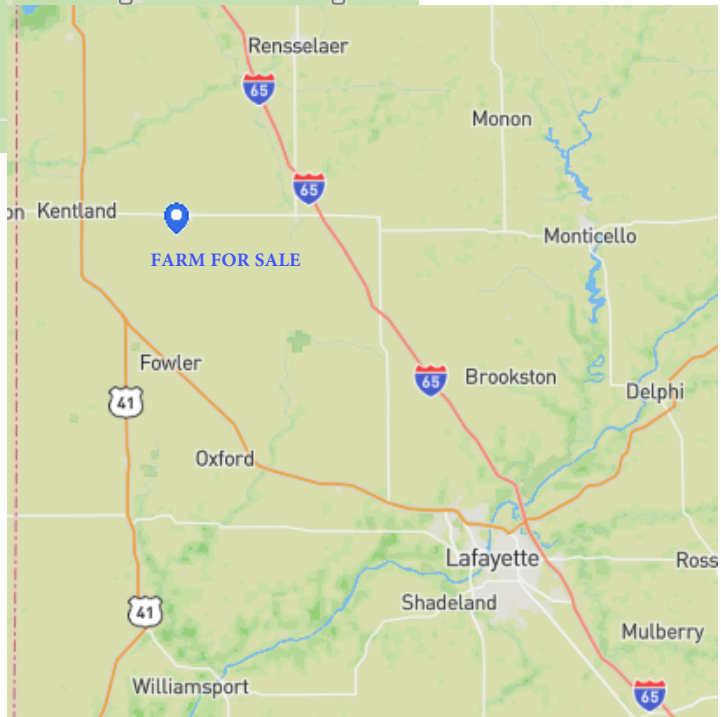
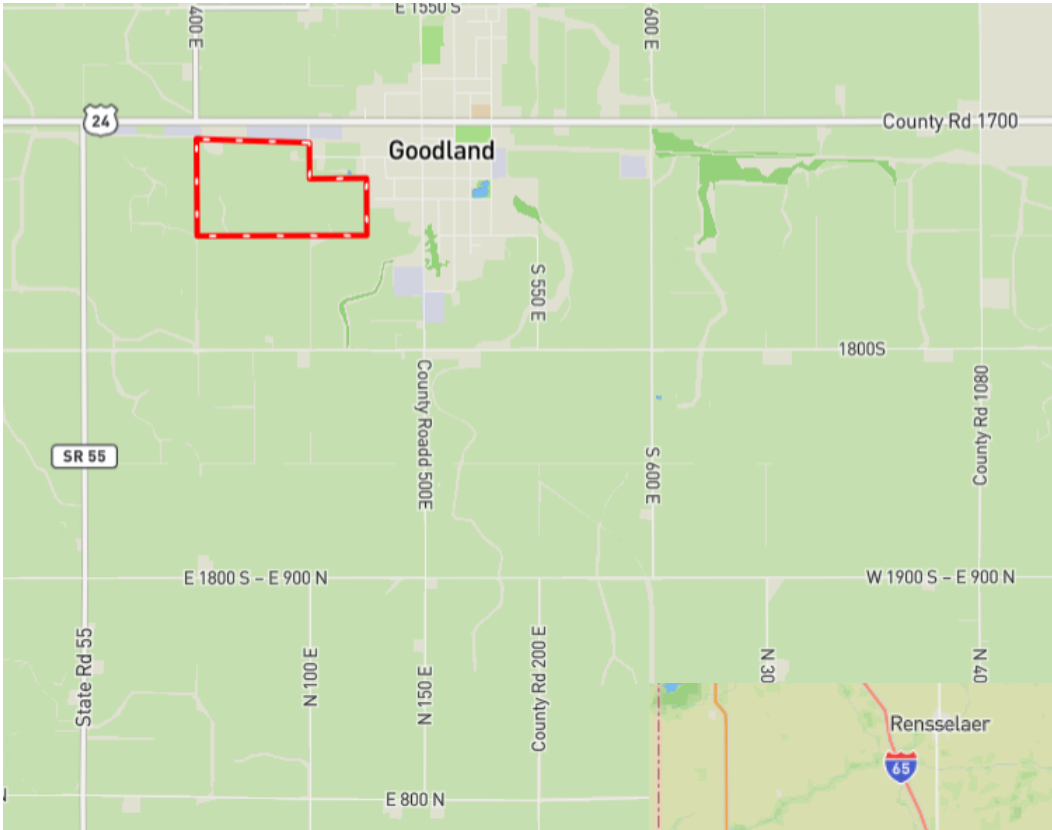

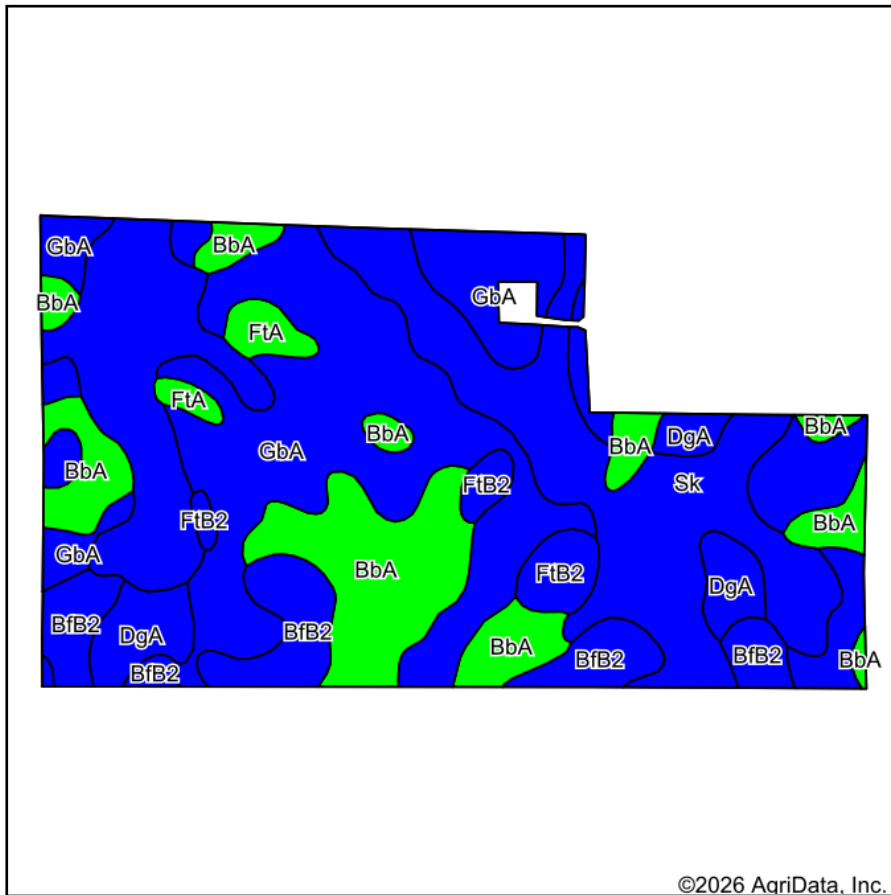

Farm Location

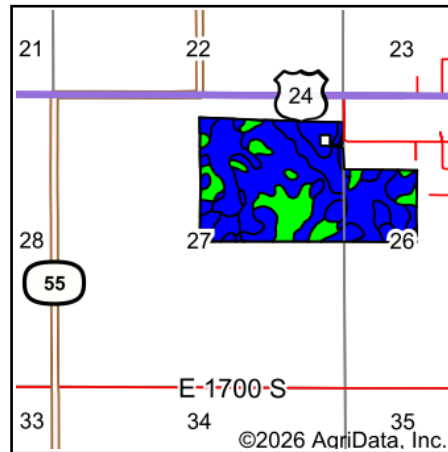


Pepsi Brookman Soils Map
